**ELIGIBILITY OF DOGS:** Dogs six months of age or older and registered with the American Kennel Club are eligible to participate in earthdog tests, as are spayed and neutered dogs and dogs with Limited Registration provided they are classified as eligible breeds. Dogs of an eligible breed that have been granted an Indefinite Listing Privileges (ILP) or a Purebred Alternative Listing (PAL) are eligible to participate. A dog of an eligible breed with an acceptable foreign registration number is eligible to participate subject to Chapter 11, Section 1 of the Dog Show Rules. Bitches in season are not allowed.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Please be ready to show proof of Rabies vaccination.

The following breeds are classified as eligible to participate in earthdog tests: Dachshunds, Miniature Pinschers, Miniature Schnauzers, and the following Terriers: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Fox (Smooth and Wirehaired), Glen of Imaal, Lakeland, Manchester, Miniature Bull, Norfolk, Norwich, Parson Russell, Rat, Russell, Scottish, Sealyham, Silky, Skye, Welsh, West Highland White and Yorkshire. Dogs that are blind or deaf shall not be eligible.

Dogs may enter more than one regular class at an Earthdog test provided the dog is eligible for the class. The Senior Earthdog class is open only to dogs that have acquired the Junior Earthdog title prior to the closing of entries. The Master Earthdog class is open only to dogs that have acquired the Senior Earthdog title before the closing of entries. Bitches in season shall not be eligible to enter the test. Entry fees paid for a bitch that comes into season shall not be refunded. Should the committee or the Judge deem conditions are unsafe to run or continue the test, no refund of entry fees will be made.

**RUNNING ORDER:** Dogs will be run in the order that entries are received with consideration given to dogs being handled by the same handler. Dogs and their handlers for the Master Earthdog class **must** be present on the grounds for roll call and bracing. **Move ups will be honored.**

**BARKING.** This is a residential area. The barking of dogs must be kept under control **at all times, including dogs in x-pens during the tests.** Winnebago County fines range from \$50-\$500 for nuisance barking complaints. The Earthdog Test Committee will enforce this rule, up to and including AKC misconduct charges.

**CLUBHOUSE:** No dogs allowed in the clubhouse.

**AWARDS:** Rosettes are offered to qualifiers in Junior, Senior and Master Classes, except those competing for Endurance Earthdog legs. Ribbons are offered for all qualifiers in Introduction to Quarry.

## “Best Practices” for the Well Being of Dog Sport Participants during these tests:

**Practice social distancing and avoid congregating to the extent possible.**

Please do not attend these trials if you have:

- a fever, cough or flu-like symptoms
- tested positive for COVID-19 and have not had a negative test since testing positive
- traveled internationally in the past month
- been in unprotected contact with someone with COVID-19 in the past 14 days.

Please bring/wear your own mask (disposable or cloth). Masks may be required in public locations in the Roscoe area.

Feel free to wear gloves if you choose to do so.

Hand sanitizer, disinfecting spray or wipes and soap for hand washing will be available in the clubhouse.

Avoid touching dogs that are not your responsibility.

Please give your entries and fees to the secretary, then leave the area. The secretary may be set up outside. Do not congregate around the secretary's table! Please pay entry fees by check made out to WHWTCNI. If paying in cash please bring the correct change to avoid an exchange of money.

Weather permitting, roll call and bracing will be held outside to avoid crowding.

Inside seating will be limited.

Weather permitting, rosettes and prizes will be available for pick-up outside (no handshaking).

If it is hot:

There will be dog cooling pools and water stations provided. Please bring plenty of your own water for both you and your dog(s).

We will try to balance taking things slow and easy, while keeping the trial moving. Volunteers will be needed! Please bring hats, sunscreen, etc. to make being in the field more comfortable.

Roscoe, IL is east of Rockford, IL and south of Beloit, WI

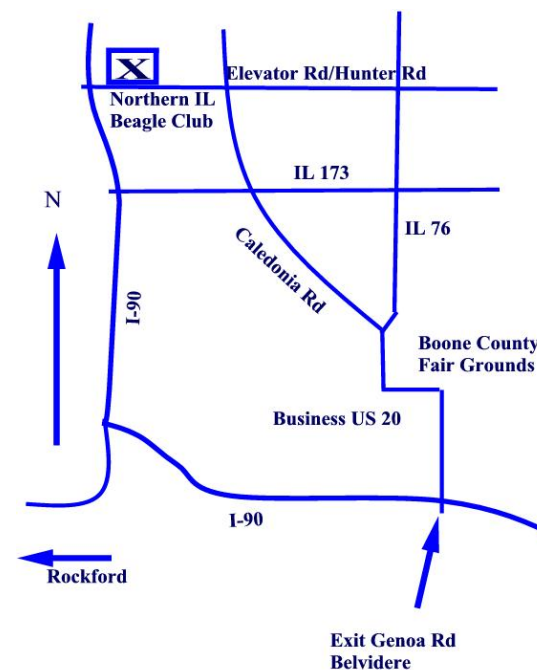
### FROM WISCONSIN

I-90 North or South to Exit # 3 - Rockton Road  
Rockton Road West to Willow Brook Road (.1 - .2 mile)  
Willow Brook Rd South to Elevator Road (2.1 miles)  
Elevator Road East to Brace Club (3.1 miles).

### FROM THE CHICAGO AREA

I-90 North to Genoa Road - Belvidere  
Genoa Road North to IL 76 (Boone County Fairgrounds are on the right)  
(Genoa Road changes names, crosses IL 20 & becomes Business 20)  
Continue on this road until you reach IL 76  
IL 76 North (right) to Caledonia Road  
Turn left at Caledonia Road  
Continue until Caledonia Road ends at Hunter Rd  
Turn left - Hunter Road becomes Elevator Road in Roscoe
